At Helen Allison School we aim, within a safe environment, to provide students with the skills, knowledge and understanding to develop online safety skills that will keep themselves safe online within the school and beyond, now and in the future.

This includes learning about:

- How to report concerns.
- Teaching who a stranger is.
- Never arranging to meet with people they meet online.



The Prevent Duty is the duty in the Counter-Terrorism and Security Act 2015 on specified authorities, in the exercise of their functions, to have due regard to the need to prevent people from being drawn into terrorism.

All staff at Helen Allison School have received PREVENT training and understand our duty to report possible radicalisation.

If you have any concerns related to possible radicalisation please contact a member of our safeguarding team who will follow procedures, which will include completing a CPOMs form.

if a visitor has a concern, they are to speak to a member of the safeguarding team prior to leaving the building.

How to Report Concerns

At Helen Allison School we have a system for reporting and recording concerns relating to suspected emotional, physical, neglect, sexual or mental abuse.

We take all concerns seriously. Our safeguarding system includes initial completion of a CPOMs form for any concerns. Our Designated Safeguarding Leads will be able to advise you and answer any questions in relation to completing CPOMs forms. CPOMs forms are online but we also have a hard copy at reception.
